# Update on Mud Creek line property

A February 2019 newsletter article concerned a rezoning application for a Cobb County property that contains a trench from the 17-19 June 1864 Mud Creek Line. The property was the subject of a previous unsuccessful rezoning application (December 2016 newsletter). The property is on the north side of Dallas Highway. GBA recently checked on grading at the site.

View of the site from Dallas Highway, looking north.



Today's Dallas Highway now bisects the ridge that was part of the Mud Creek line. In this view looking west, the modern bridge over the creek is in the middle distance, and the road rises to the Federal position farther west. A 1952 historical marker is on the right, and an identically worded recent brighter green marker is on the left. Property is to the right.



Extensive grading has removed many of the trees. Looking west, Garrison Commons Road is in the foreground and Dallas Highway (marked by power line pole) is to the left. Although GBA has been denied access to the site, we believe the orange construction fencing and the tree line beyond still protect the remnant of the Mud Creek Line.

# 150 years ago this month – February 1870

Now that it is a condition for readmission to the Union, the Georgia legislature on 2 February ratifies the 15<sup>th</sup> Amendment, which states that the right to vote shall not be denied on account of race, color, or previous condition of servitude.
